


Figure 1. Bar diagram showing subject wise average score of responses given by B. Com. I Students




Figure 2. Bar diagram showing subject wise average score of responses given by B. Com. II Students




Figure 3. Bar diagram showing subject wise average score of responses given by B. Com. III Students




Figure 4. Bar diagram showing subject wise average score of responses given by BBA I Students




Figure 5. Bar diagram showing subject wise average score of responses given by BBA II Students




Figure 6. Bar diagram showing subject wise average score of responses given by BBA III Students




Figure 7. Bar diagram showing subject wise average score of responses given by M. Com. I Students




Figure 8. Bar diagram showing subject wise average score of responses given by M. Com. II Students




Figure 9. Bar diagram showing subject wise average score of responses given by MBA I (SEM I) Students




Figure 10. Bar diagram showing subject wise average score of responses given by MBA I (SEM II) Students




Figure 11. Bar diagram showing subject wise average score of responses given by MBA II (SEM III) Students




Figure 12. Bar diagram showing subject wise average score of responses given by MBA II (SEM IV) Students




Figure 13. Multiple bar diagram showing statement wise frequency distribution of responses given by teachers




Figure 14A. Multiple bar diagram showing statement wise frequency distribution of responses regarding institution given by alumni




Figure 14B. Simple bar diagram showing statement wise frequency distribution of responses regarding syllabus contents given by alumni




Figure 15. Cylinder bar diagram showing statement wise frequency distribution of responses given by parents
